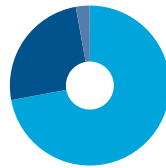

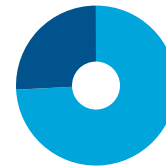


## ASSET ALLOCATION



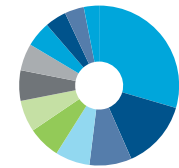
