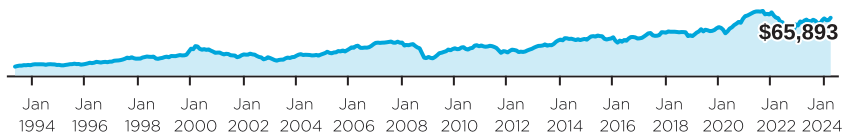

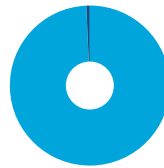

### ASSET ALLOCATION



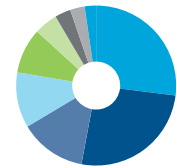
