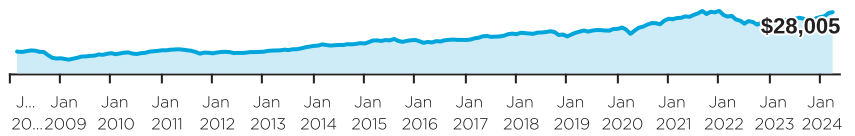

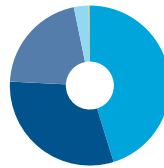

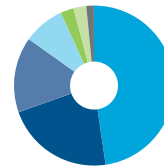


### ASSET ALLOCATION



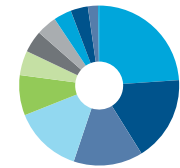
