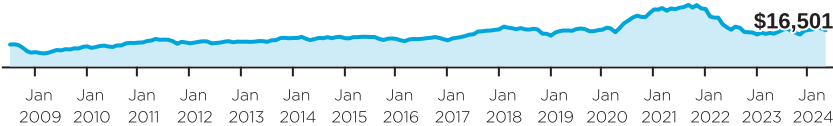

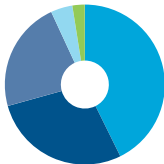

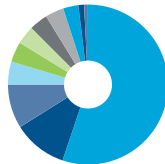


ASSET ALLOCATION



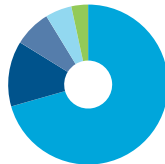
