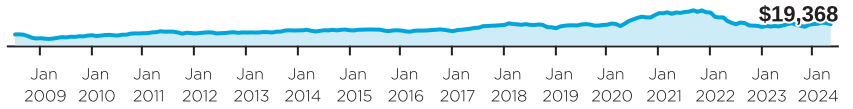

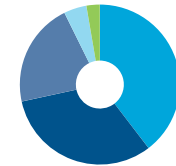

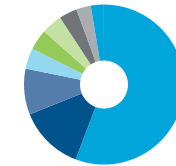


ASSET ALLOCATION



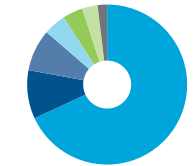
