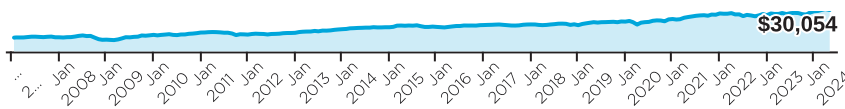

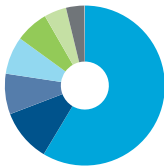

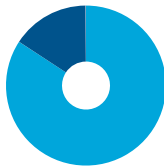


**ASSET ALLOCATION**
