

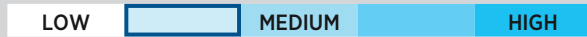

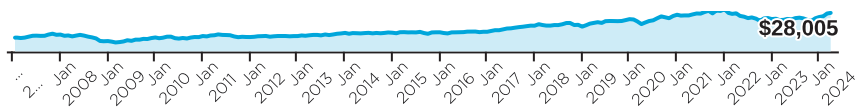

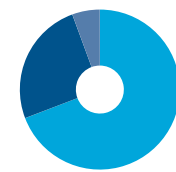
### WHY INVEST IN DYNAMIC GLOBAL DIVIDEND CLASS ?

### GROWTH OF \$10,000

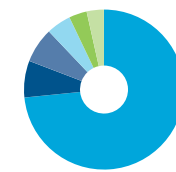


### ASSET ALLOCATION



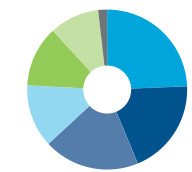
