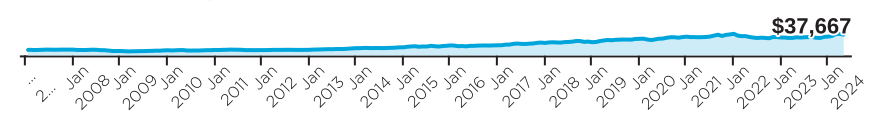

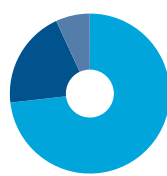
WHY INVEST IN DYNAMIC GLOBAL DIVIDEND CLASS ?

GROWTH OF \$10,000

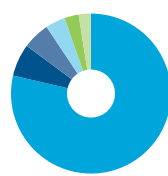


ASSET ALLOCATION



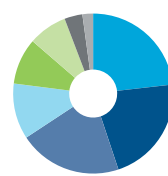
