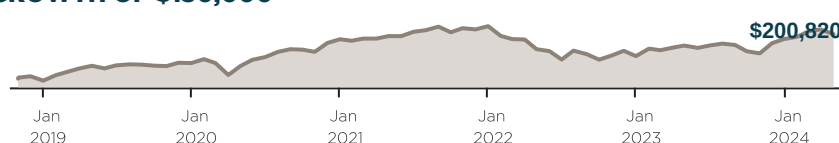

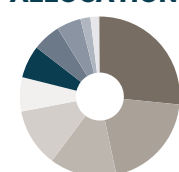
INVESTMENT DISCIPLINE

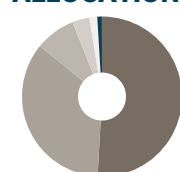

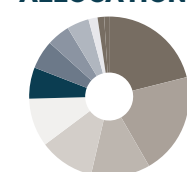
