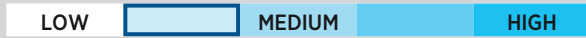

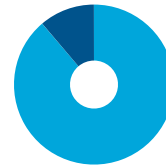


**ASSET ALLOCATION**



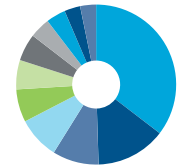
