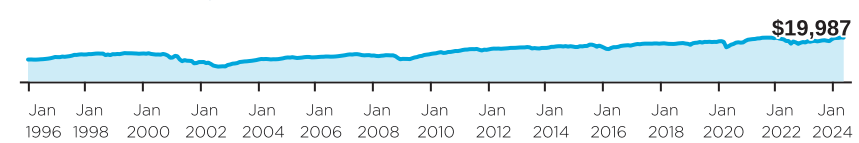

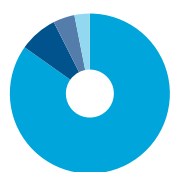

GROWTH OF \$10,000

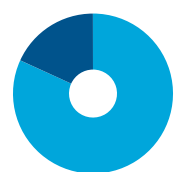


ASSET ALLOCATION<sup>6</sup>



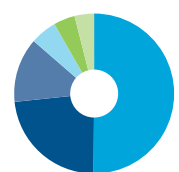
