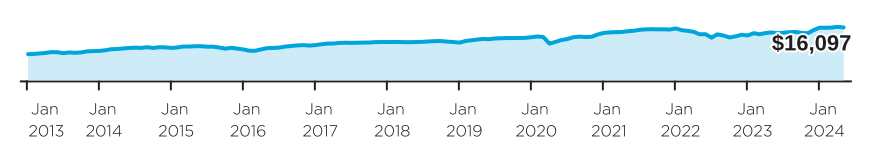

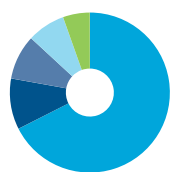
WHY INVEST IN DYNAMIC CREDIT SPECTRUM FUND ?

GROWTH OF \$10,000

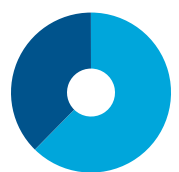


ASSET ALLOCATION⁶



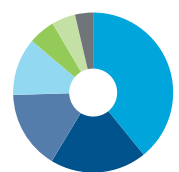
