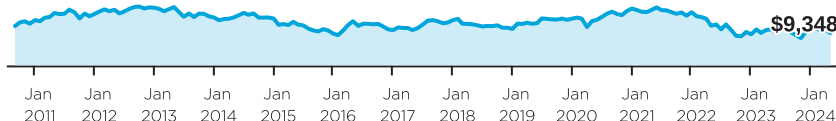

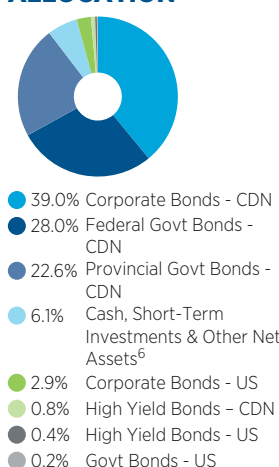
### WHY INVEST IN DYNAMIC TOTAL RETURN BOND CLASS ?

- Strategies to mitigate risk include active security selection, sector diversification, yield curve and duration management and portfolio diversification around interest rate volatility

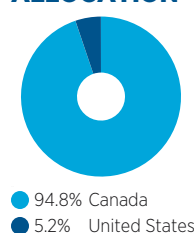
### GROWTH OF \$10,000



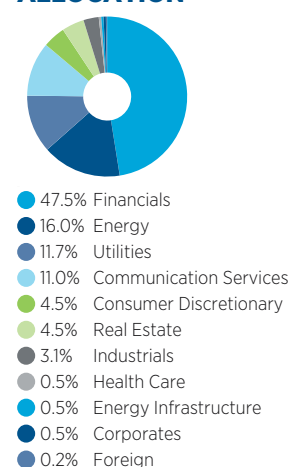
### ASSET ALLOCATION
