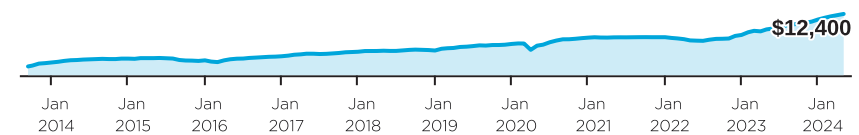

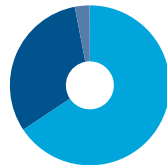
WHY INVEST IN DYNAMIC INVESTMENT GRADE FLOATING RATE FUND ?

- Floating distribution that fluctuates with prevailing Canadian short-term interest rates.

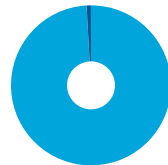
GROWTH OF \$10,000



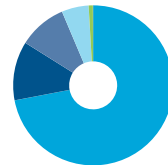
ASSET ALLOCATION
