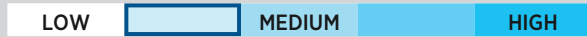

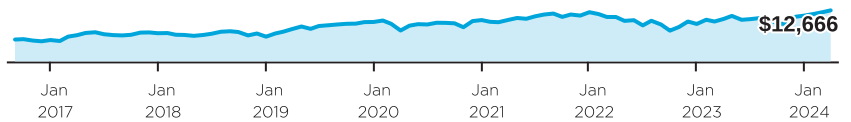

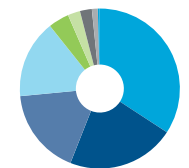

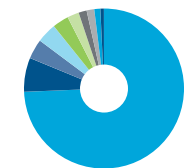


**ASSET ALLOCATION<sup>8</sup>**



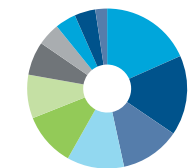
