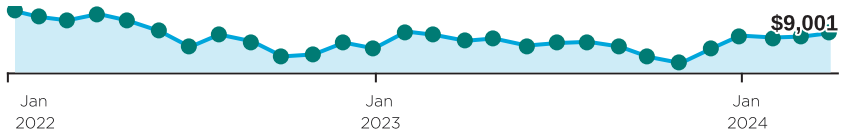

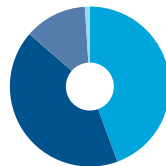

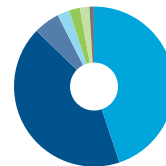


ASSET ALLOCATION



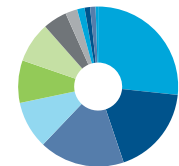
