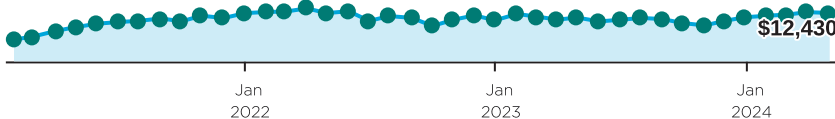

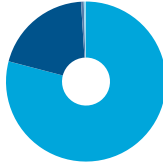


ASSET ALLOCATION



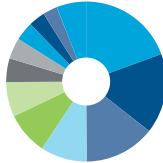
