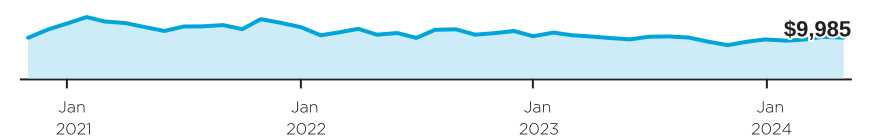

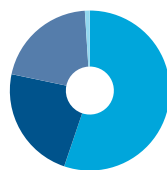

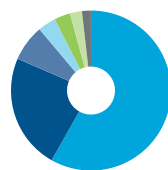


ASSET ALLOCATION



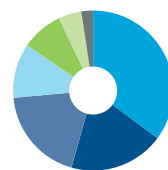
