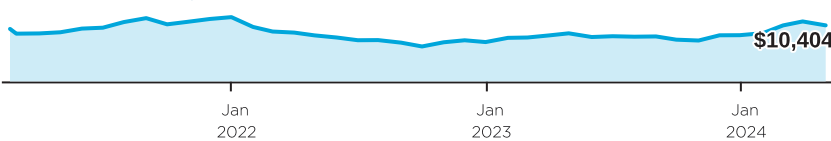

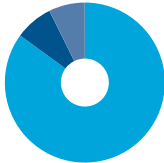
WHY INVEST IN DYNAMIC INTERNATIONAL DISCOVERY FUND ?

GROWTH OF \$10,000

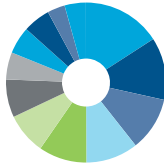


ASSET ALLOCATION



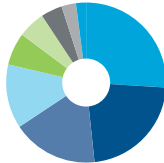
