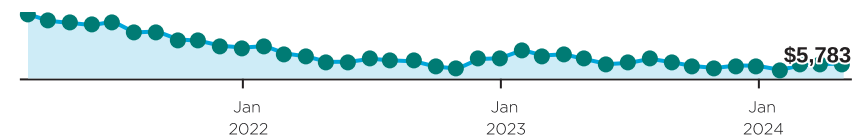

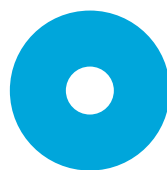

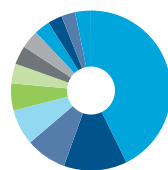


ASSET ALLOCATION



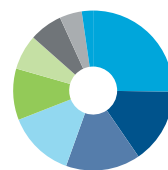
