

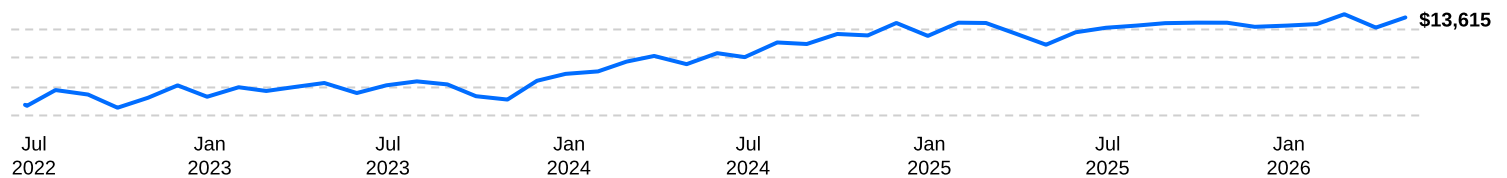

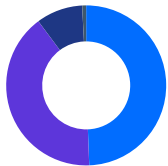
Why invest in Dynamic Sustainable Equity Fund ?

Growth of \$10,000

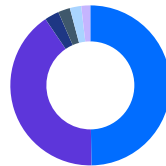


Asset Allocation (%)



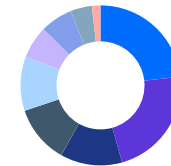
